I'm not saying howling into the night like a wolf will work for you, but there are other ways of dealing with rage.

With regard to the Wi-Fi, yes, the Wi-Fi in the west of this country is the worst in Europe. There is nothing we can do about this for the moment, although I think we are getting high-speed broadband in the area pretty soon.
